Degree documentation indicating the scores obtained in each examination and the degree vote or high school degree vote, translated in Italian language by an official legal translation and a certify transcript released by an Italian Representative of the foreign country in which the qualification is obtained – (only if the candidate has a non-Italian qualification degree);
6. Regulation (indicating the rights, duties and responsibilities during the training student), duly signed;
7. Motivation letter (or presentation letter of a professor of the university).

The candidate's declaration must be signed and submitted with a copy of valid identification document or made in the bottom of the photocopy of the document itself to stating of the original. It shall retain the right for the University to carry out the investigation of the veracity of the certification decisions or acts of notoriety made by candidates, in accordance with the aforementioned legislation. Therefore, the applicant must provide all the data necessary to enable the Administration to investigate. In the case of incomplete declarations, the Admissions Commission may require amendments and / or clarifications to the candidate and / or the Administration, in order to admit to the title evaluation self-certified, Please note also, that false and false statements are punishable under the penal code and special laws.
